



Network Unit Tokens Crowd Sale Agreement

These terms define terms of use of the Network Units Smart Contract and tokens on the decentralized distributed Ethereum blockchain.

Nature and use of smart contract and tokens

Network Units smart contract (hereinafter 'smart contract' or 'software') is a software deployed and working on the decentralized distributed Ethereum blockchain (hereinafter 'Network').

This software was initially developed and deployed by Evil Badger (hereinafter "Company," "we," or "us"). Network Unit (NU) Tokens (hereinafter 'tokens') are part of the software and ensure its interaction with the Network.

By using smart contract, including its tokens you expressly acknowledge and represent that you (hereinafter 'User' or 'you') have carefully reviewed and accepted this agreement between you as a User and the Company.

This agreement is deemed to be concluded in Australia between you and the Company on the date and time you start using the Software.

Purpose of the smart contract and tokens

The purpose of the tokens is to be used to drive our economy of Service Providers, Active Clients and Developers. NU Tokens are virtual items used as a currency within the Network Units Platform.

Liability

We are not liable for any lost funds if an unsupported wallet is used by you. Please use one of the suggested wallets listed on our ICO announcement website, or do your own research into a preferred wallet to check if it is supported.

Converter

Any countdown timers, converters and calculators on the website at times, may be inaccurate. It is your responsibility to make sure that your timing is correct and that the amount you are transferring equals to the amount agreed upon by the smart contract and the terms. Every 1 ETH transferred will result 500 NU as well as any quantity or period bonuses incurred.

Description of the software

Due to the nature of the Network code of the working software, it cannot be changed after deployment. The maximum number of tokens implemented in the software is determined by the amount of ETH transferred during the ICO period. A maximum (hard cap) of 28,758,333.33 tokens will be created (minted).

Dispute resolution

Any dispute, controversy or claim arising out of or relating to this agreement, or the breach, termination or invalidity thereof, shall be settled by arbitration in accordance with the [IACC Arbitration Rules] (https://github.com/Cryptonomica/arbitration-rules/tree/master/Arbitration_Rules/IACC) in the version in effect at the time of the filing of the claim. And unless the parties agree otherwise in writing: - The language to be used in the arbitral proceedings shall be: English.

Any dispute arising out of or related to this agreement is personal to you and Company and will be resolved solely through individual arbitration and will not be brought as a class arbitration, class action or any other type of representative proceeding. There will be no class arbitration or arbitration in which an individual attempt to resolve a Dispute as a representative of group of individuals. Further, a Dispute cannot be brought as a class or other type of representative action, whether within or outside of arbitration, or on behalf of any other individual or group of individuals.

Pre-ICO Participation

Participation in the Token Presale provides a varied bonus rate multiplied on the base conversion rate depending on the quantity contributed. Bonus Tokens will be unlocked in phases. These bonus rates and phases are coded into our smart contract which can be located here:

Token Presale contributions are mainly non-refundable as all funds raised will be withdrawn, converted to fiat, and then used to further market the main Crowdsale. Any remaining funds (if any) will be refunded if the main ICO does not reach its set minimum.

ICO Participation

If the ICO does not reach set minimum, 100% of all funds contributed during the main ICO period will be refunded, minus any Gas.

Severability

If any term, clause or provision of these Terms is held unlawful, void or unenforceable, then that term, clause or provision will be severable from these Terms and will not affect the validity or enforceability of any remaining part of that term, clause or provision, or any other term, clause or provision of these Terms.
